By signing up for and being allowed to participate in classes and activities operated by New Movement Collaborative LLC, hosted at Green Street Studios, their subsidiaries, affiliates, employees, instructors, independent instructors, I hereby understand, agree and acknowledge on behalf of myself assigns the following:

I will be attending classes, activities and other programs utilizing facilities and equipment and performing exercise at Green Street Studios through New Movement Collaborative from which there are inherent risks and dangers in association therewith, which can include but not be limited to physical injury to my legs, knees, back, shoulders, head, injury or strain to the cardiovascular, circulatory and/or respiratory systems and injuries to other parts of the body.

I have no known medical or physical condition (including pregnancy), mental or emotional disability including but not limited to cardiac irregularity, episodes of dizziness, asthma or other breathing difficulties, diabetes, neurological disorders, spinal joint tendon or ligament injuries, high/low blood pressure or any other disability that would put me in any physical or medical danger or prevent or limit me from attending any New Movement Collaborative classes.

I have not been advised by a physician to limit my physical activities and I am not under the influence of any medication or substance that would prevent such participation. It is the recommendation of New Movement Collaborative LLC and Green Street Studios that I consult with a physician before participating in classes and that my participation in such classes is purely voluntary at my own risk and that I agree to assume all risks related to or inherent in such participation, which may include and not be limited to risk of serious physical injury, lightheadedness, fainting, fluctuations in blood pressure, fluctuations in my heart rate and there is also risk of death. The instructions and advice of instructors is not to be construed by me to be medical advice.

If in the opinion of New Movement Collaborative LLC my access or participation may endanger my health or the health of others then New Movement Collaborative LLC may deny me access and the right to participate until I furnish a letter from my physician stating that in the opinion of such physician I am medically and physically able to participate.

I must adhere to all of New Movement Collaborative LLC purchase and cancellation policies and agree that all sales are final. Neither Green Street Studios nor New Movement Collaborative LLC is in any way responsible for the safe keeping of my personal belongings while I attend a class and that any storage capability that is provided for my use by NMC LLC is strictly as a courtesy for my own benefit and at my own risk.

AND CAUSES OF ACTION (CLAIM) THAT MAY ARISE FROM MY PARTICIPATION REGARDLESS OF HOW SUCH CLAIM MAY HAVE COME ABOUT.

In the event any portion of this agreement is deemed to be not enforceable, then it shall not impair the remainder of the agreement.
